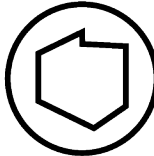

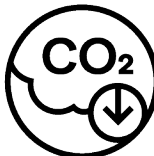

- Colors must be defined exclusively using the Pantone Matching System (PMS) for coated papers ©. All displayed colors are for visual reference only and should not be considered the actual color of the final product or print. A color tolerance of ±2 PMS tones shall be acceptable to the Client.
- If colors are not specified using the Pantone Solid Coated scale, we do not take responsibility for color accuracy after printing.
- Due to technical limitations, logo centering may vary in mass production. The distance between the logo and the edges of the fabric/tape may differ by ±2 mm or 20% of the imprint size.
- To ensure the legibility of graphics in the designs, the Seller requires:- A minimum text height of 1.5 mm for tapes T1, T7, T8, T9, T10, and T16 - A minimum text height of 2 mm for bandanas, microfiber cloths, and mousepads.
- We reserve the right to adjust the design and logo positioning to meet the requirements of the relevant printing technology.
- The Client is responsible for any errors (spelling, typography, logo, font, etc.) found after the final proof has been approved. Complaints regarding design errors after approval will not be accepted.
- For files submitted in bitmap format only, we cannot guarantee print color accuracy, sharpness, or visibility. Complaints related to this type of graphic will not be accepted. We strongly recommend preparing a sample before proceeding with production.
- For lanyard orders with a safety break, we recommend positioning the safety break approximately 10–15 cm above the metal hook, rather than on the neck. If the safety break is placed on the neck, the Client assumes full responsibility for any potential itching or irritation that may occur while wearing the lanyard.
- Before proceeding with mass production, we strongly recommend creating a pre-production sample. If no sample is made, post-production claims will not be accepted.
- All re-orders are treated as new orders, and the same terms and conditions apply. By placing a re-order, the Client acknowledges that there may be color differences between previous and new production runs.
- The Client assumes full responsibility if the execution of their order results in the violation of third-party rights. The Client shall indemnify and hold the manufacturer harmless from any third-party claims arising from such violations.
- If the shipment of an order is postponed by the Client, the order will be stored at the Client's expense and risk.
